EXECUTIVE SUMARY



Reviewing this annual report, you will see we have accomplished several key initiatives related to our strategic plan and, more importantly, created strong and lasting bonds with our community partners. We believe that the rights of people with intellectual and developmental disabilities (I/DD) should be protected and that they will experience improved health, safety, and community connections with the support they need.

We hope to be a leader in inclusiveness efforts in our community. Our mission states that The Arc Tennessee empowers people with intellectual and developmental disabilities and their families to participate actively in the community throughout their lifetime. We strive to pursue that mission with the work that every person on The Arc Tennessee team does. Every day we advocate and educate within our schools, human service agencies, workplaces, government departments, and the community to raise awareness of the role of people with developmental disabilities as contributing members of their community.

Connection is critical to The Arc Tennessee's work; connection was a significant highlight of 2023! We have been so encouraged by the successful in-person events we have held this year, including our family day at the zoo for families with school-aged children, a People First Pre-Halloween Party in Chattanooga, and of course, we are preparing for our first in-person Mega conference since 2019!

In 2023 The Arc Tennessee was successful in renewing our Advocacy and PASS Contracts with the state, and we are honored that we have been entrusted to continue to do this critical work. We work daily to protect people with intellectual and developmental disabilities right to self-determined lives free of denials of needed services, discrimination, abuse, neglect, and exploitation, or the threat of it.

The 2023 Legislative session recently wrapped up. The Arc Tennessee was actively opposed to proposed legislation that would have allowed mechanical restraints for children with disabilities and created boarding schools for at-risk students, including those with disabilities. Our action alert system was invaluable in harnessing the grassroots power of individuals and families to make their voices heard. Disability Day on the Hill on March 8th was a fantastic opportunity for Tennesseans with disabilities to meet with their legislators and tell them what is most important to them. In addition, the Arc Tennessee delivered the 2023 Vanderbilt Kennedy Center's Kindred Stories of Disability booklet, Mental Health, and Disability, to legislators' offices.

The Arc Tennessee is prepared and ready to continue to be the leading advocacy organization for people with Intellectual and Developmental Disabilities (IDD) and their families In Tennessee.

Thank you to everyone who has helped The Arc Tennessee this year and in years past to achieve this raission. We could have we do without you!


We are driven by the following values: Integrity, Justice, Courage, Respect.


STRATEGIC PLAN

MEMBERSHIP & LOCAL CHAPTERS

This year The Arc Tennessee has added 604 new members, for a total of 2,172 members! Each affiliated local chapter has its own 501(c)(3) nonprofit organization and serves their communities through a variety of direct services. Some chapters serve multiple counties, while others are county specific. As the state chapter, we provide local chapters with technical assistance, training, and membership processing. Our 15 local chapters are an important part in achieving our overall mission and we take great pride in seeing our local chapters succeed. June 2023 will mark the beginning of the 3rd year that The Arc Tennessee has been using an integrated membership data and customer relationship management system. With two years of data compiled, the database provides the capacity to report and analyze data in a variety of formats increasing perspective for engagement and outreach to prospective communities/counties as well as established areas. Collected information provides a foundation to set and attain data driven membership goals.

In May 2022, we launched Membership Lunch & Learns where staff from local chapters are invited to attend virtual meetings discussing topics such as digital design, event planning, and membership support. In addition, we launched a membership pilot with The Arc Williamson County and The Arc Davidson County and Greater Nashville. Over 10 months, data was collected and reviewed creating sustainable systems of processing membership with flexible options to meet distinctive chapter needs of local chapters. With the introduction of targeted email, online forms, and customer relationship management, The Arc Tennessee has laid a strong foundation for increasing retention of current members and extending our reach to new members and...





OTHER EVENTS

During Fall, 2022, The Arc Tennessee, along with the Family Engagement Team, hosted "Up Close & Wild" at the Nashville Zoo. This event, which had over 140 people in attendance, created a an outdoor, accessible venue where families could come together. During this event, a meal was provided and families had the opportunity to have a professional family photo taken. Families were also able to learn about specific animals during the "animal meet and greets," take their turn on the zipline or carousel, enjoy face painting, and spend as much time visiting the different animal exhibits while on site. After the event, we learned this was the first time many of these families felt comfortable getting out in public together post-COVID 19. On our event survey, 100% of respondents said they would recommend the event to a friend and were hopeful this would be an annual event!

2022-2023 PROGRAM IMPACT ADVOCACY + AWARENESS

For The Arc Tennessee's advocacy team, this last year has brought an array of new opportunities and experiences. As we have begun to emerge from the public health emergency that has caused such uncertainty over the last three years The advocacy team has worked continuously to help individuals and families receive the support they need in order to get back into the community.


Over the last year, we have seen an implementation of new programs created to help meet the needs of individuals living in Tennessee with intellectual and/or developmental disabilities such as MAPs, the extension of TEIS services to age 4, and a recent partnership between DIDD and DCS to help support children in the foster care system with IDD. We also saw the addition of 2000 spots open in the ECF waiver.

To help keep our advocacy team growing and learning we have worked to assure that advocates are trained and well-versed in any new programs and that they are a part of the conversations happening about programs and changes at the systems level. Our team has taken part in the State's various Policy and Planning committees, Family Support Council, Autism Council, ECF Advisory councils, and meets regularly with DIDD Leadership at the regional and central level to work towards ensuring the needs of those supported are being met and to create open lines of communication.

ADVOCACY + AWARENESS (cont.)

We have continued to institute the use of a secure database and online referral form. The database has made it possible for us to securely and easily put in notes on individual cases as well as save needed documentation to a person's records to assure we are fully aware of the whole picture and can assist in the best way possible. The database has given us the ability to more easily collaborate across regions as well as be able to track data for reporting purposes and be able to identify emerging trends in advocacy work. An added bonus to the use of the database is that it gives us the ability to collect stories from individuals and families that can then be shared to help produce systems change. Our movement towards using an online referral process is that it has helped us to better collect needed information as well as have a streamlined approach for the referral process. The referrals we receive can come from families, individuals, Support Coordinators, MCO's, DIDD, school systems, social workers, provider agencies, and many others that are looking for advocacy support in many different forms.

In order to meet the needs of the changing systems, the advocacy team conducts in-person meetings quarterly to evaluate progress on individual goals and team goals. These meetings give us the opportunity to also address what's working and what's not working in our advocacy work and work towards solutions. In September of 2022, eight members of The Arc team participated in PATH (Planning Alternative Tomorrows with Hope) training so that we can provide this person-centered service to individuals, families, and agencies that request it across the state.

PERSONAL ASSISTANCE, SERVICE, AND SUPPORTS (PASS) PROGRAM

Through grant support from DIDD, The Arc Tennessee supports six individuals with developmental disabilities to self-direct their supports and services. This program created the model for self-direction in Tennessee. Individuals in the PASS Program do not receive other home or community-based services but need supports to live independently in the community. Most participants in the PASS Program work in competitive jobs. We support these individuals to manage their budgets, pay their support staff, and find creative technology solutions that increase their quality of life.

FAMILY ENGAGEMENT

Family Engagement in Special Education is a collaborative project of The Arc Tennessee and the Tennessee Department of Education. Our team helps to empower parents and caregivers and increase family engagement in special education by building a bridge that connects families and school in a variety of ways. We want families to find success in their special education experience.

We reach families statewide in many ways including a monthly enewsletter, social media, our website and more. This year we revamped our website with resources for families and teachers at FamilyEngagementTN.com. We work closely with the team at the Department of Education to provide information to families through regional events, monthly blogs, and social media posts. This past year we grew our team of Regional Family Engagement Specialist to eight, ensuring we can provide support to families and districts across the entire state of TN through support groups, advisory councils, resource fairs and much more.

PEOPLE FIRST TN



The Arc Tennessee supports self-advocates as they learn leadership and important relationships through the People First project, which is funded through a partnership with the Department of Intellectual and Developmental Disabilities (DIDD). People First Tennessee has an active Advisory Council with membership from across the state. They are recruiting members and developing local chapters.

These are some of our recent notables:

- Participated in 'Empowered Gents' sessions: a social group that gathers to learn about assistive technology and other resources that increase the independence and confidence of men with disabilities. Participants share experiences and life hacks with their peers.
- Participated in Bi-monthly Southeastern Regional Superhub Meetings on Vaccination efforts.
- Ongoing weekly Thursday afternoon National Self-Advocacy Zoom meetings, where ideas for community-partnership and additional resources are shared through SARTAC (Self Advocate Resource and Technology Access Center).
- People First's Frank Meeuwis and Lisa Gail Newby co-presented to the Middle-TN Policy Planning Council on success from the Summer Freedom Fest '22, and about ongoing efforts to keep growing and tell others about People First Tennessee.
- Ongoing collaboration with SABE, the National Self Advocates Becoming Empowered group, to share latest on community safety and important legislation.

PEOPLE FIRST TN (cont.)

- Presented on People First's history, mission, and ongoing work to raise the voices of people with disabilities at Vanderbilt Kennedy Center's Community Advisory Committee.
- Volunteered and promoted People First at the Bellevue Park
 Center for a community gathering of people with disabilities from
 Rochelle Center, a disability services and support organization in
 Nashville.
- In October at the Jack Benson Park in Chattanooga, with local food sponsorship from Chick-fil-A, People First hosted a Pre-Halloween Party for nearly 150 individuals, family members and support professionals.



TENNESSEE CENTER FOR DECISION-MAKING SUPPORTS

The Arc Tennessee continued to manage the TN Center for Decision–Making Support for FY 2022–2023. The grant from the Council of Developmental Disabilities ended 6/30/2022 which also ended the partnership with Disability Rights Tennessee. The Arc Tennessee became solely responsible for the operations and financial support for the TN Center for Decision–Making Support.

CDMS started negotiations with TennCare to support CDMS through the Money Follows the Person (MFP) Grant. This grant was anticipated to start in the fall of 2022 but was detained due to contract revisions. With this grant, TennCare would support the general duties of CMDS and would include a new project called the MFP System Transformation Initiative (STI). Under this project, CDMS would work with TennCare to implement Supported Decision-Making practices and tools to help individuals exiting Immediate Care Facilities (ICF) placement and moving them into integrated community living and employment. This project start date was postponed and is now anticipated to start June 2023.

With the loss of the legal support of Disability Rights TN, the Center needed to find new legal support which resulted in developing collaborations with other legal partners such as a liaison with DIDD OGC, CDMS Advisory members who are attorneys, the Office of Conservatorship Management, and the Conservatorship Association of Tennessee. With the development of these collaborations, the Center was able to obtain free legal counsel to provide advice to the Center, when appropriate, to ensure CDMS continued to provide non-biased accurate information, without providing legal advice to families.

As a result of the contract changes, CDMS disbanded the original CDMS Advisory and developed a new CDMS Advisory. The role of the new CDMS Advisory is to help direct CDMS into the new project and growth of CDMS under the new grant. The Advisory meets quarterly and is comprised of advocates professionals across the disability committee. CDMS continues to retain the Training and ...

TENNESSEE CENTER FOR DECISION-MAKING SUPPORTS (CONT.)

Development Committee to assist with the ongoing development of videos, webinars, and materials for the CDMS website.

The loss of the support of Disability Rights Tennessee also increased the direct workload of CDMS staff, having to conduct all education, outreach, on-on-one consultations, training, and legal referrals. To help support the increase in workload, The Arc Tennessee hired a Transition Coordinator through the Family Engagement contract. The Transition Coordinator position supported both the Family Engagement Transition requirements and CDMS transition services, which included providing education on decision-making supports and transition services to youth, families, educators, and other professionals.

The Transition Coordinator was trained on Conservatorship and alternatives; Supported Decision–Making; transition services; how to use the Center website and tools; how to conduct one–on–one consultations with families; and how to manage a booth at Transition fairs. Once trained the Transition Coordinator was able to handle much of the Transition Services related to the Center. CDMS continued to oversee and manage the website and website updates; provide limited one–on–one assistance to individuals with disabilities, family members, educators and professionals; conduct webinars and presentations across the state; collaborate with DIDD and the other legal entities for complex case resolution; provide education and training regarding the usage of Supported Decision–Making tools and the website; and provide resources and legal referrals to families regarding decision–making supports.

CDMS's primary focus was to provide the ongoing information and referral services, continue to manage and update the website, increase public awareness of the Center, increase collaboration with other state agencies and organizations, and enhance resources by developing videos, trainings, and educational materials.



TENNESSEE CENTER FOR DECISION-MAKING SUPPORTS (CONT.)

* One-on-one assistance may consist of ongoing limited assistance to help resolve decision-makings support issues or obtain the necessary resources. This can include multiple calls, emails, or meetings with the individual, family, supporters, or professionals to help resolve the issue. These cases can weeks to months to resolve.

**Conservatorship cases may be coordinating with legal counsel and the Circle of Support on a conservatorship modification, rights restoration or providing assistance/support to the individual or support team to help with the process of a conservatorship legal action. This casework can take months or longer to resolve. Some of these cases were continued from FY 2022. Since CDMS did not have funds to cover legal services. CDMS worked with existing legal entities to work toward conservatorship issue resolutions.

PUBLIC POLICY ADVOCACY

Advocacy has always been, and will continue to be, the heart of The Arc Tennessee. Whether we are defending human and civil rights through public policy efforts, partnering with key stakeholders to create change in how services are delivered, or addressing an individual's personal needs, the goal is always to improve the quality of life for people with IDD and their families. Here are just a few examples of public policy advocacy in action:

- Partnered with the Vanderbilt Kennedy Center on Kindred Stories on Mental Health and Disability
- Coordinated five meetings with federal legislators during Disability Policy Seminar
- Initiated Action Alerts for State legislation
- Worked with the Disability Policy Alliance on priority legislation
- Met weekly with DIDD Legislative Liason
- Sponsored Disability Day on the Hill: The Coalition hosted over 120
 people on the DDH Legislative webinar, with 45 people watching after
 the fact. During DDH, over 150 meetings were scheduled with
 legislators, and more than 300 people showed up to advocate on The
 Hill.
